The exercise price of the Options is the closing bid price on July 2, 2020, or \$0.8439 per share. The Options shall vest equally over a period of three years from the Grant Date. Vesting is contingent upon the executive's continued employment with the Company on each applicable vesting date. The Options expire on July 2, 2024.
