The RSU's consist of (1) one award of 7,500 RSUs that began vesting in 20% annual increments on each of the first five anniversaries of March 6, 2018; (2) an award of 12,000 RSU's that vest in 25% annual increments on each of the first four
- (1) anniversaries of March 14, 2018; and (3) an award of 8,287 RSU's of which 2,762 shares will vest on December 31, 2019, 2,762 shares will vest on December 31, 2020, and 2,763 shares will vest on December 31, 2021. Each RSU represents the right to receive one share of common stock upon vesting.
- (2) The option became exercisable in 33.33% annual increments on each of the first three anniversaries of May 25, 2016. 6,666 shares are currently exercisable and the remaining 6,667 shares will become exercisable on May 25, 2019.
